## We Have Come a Long Way Baby

Jane Horning is retiring from her position as Used Clothing Chair at the Center. I wanted to know what her feelings were after working there for over 30 years. "I have loved every single minute of Christ Child," Jane said, "and you know what really impresses me is how these ladies (and men) work here year after year. I think of them a lot and the ones who have passed away. If you have a problem at home or have lost someone, the Center's a place to come for comfort and to forget your worries and have fun."

She and I started singing that old 80's song "Don't Worry, Be Happy." That pretty much is Jane's philosophy on life too. Whether she was working on fundraisers or luncheons or In Memoriams or her stint as president, she always had a smile and a positive attitude.

There were other ladies who made that department great, too, such as Anne Mc Minn, Dee Tepe and Katy Cressy. Anne helped run the Used Clothing room for many years. Dee first solicited the 14 Catholic Grade Schools in our area and did the pick up and deliveries herself. Then she added day care centers and started asking other women to help. Dee said they used to put the clothing in banana boxes; now we have nice plastic bins. Instead of a dark dungeon of a room in the basement like at the old church ours is bright and sunny. Back then we had about 30 churches etc. that we collected from. Katy Cressy became in charge of the Motor Corp. and now we have over 45 sites in Michiana, and 35 or so volunteers who pick up from the sites.

Like they say in the commercials, "We have come a long way baby" thanks to the dedication of our volunteers.
