The dinner garnered nearly \$89,000, funds that will go directly to the purchase of new clothing.

Tom Liddell handled host duties and Chuck Freeby served as auctioneer again. The live auction offered men's and women's ND-UConn tickets, premier Colts tickets, a Mass in the Log Chapel presided over by Fr. Monk Malloy and more. The Children's Choir from St. Adalbert's School sang during dinner and reminded us of the heart of our mission.

Valley Screen Process accepted the second "Heart of a Child Award" in recognition of their many years of support for the Clothe a Child Campaign. Carol Bauer, whose late husband, Jerry, co-founded Valley Screen in 1967, has been a member of Christ Child since 1981 and their daughter, Karen Barnett is also a member. Carol and Karen co-own the company and Karen is the President and CEO. Valley Screen prints and die cuts thousands of paper dolls yearly. Accepting the award, Karen noted, "We are very proud to support the wonderful work of the Christ Child Society. Through the shining example of our parents, and all the members, we are happy to be able to continue our parents' life work. National Convention

This year's Christ Child Convention was held in Detroit September 20-22 with 24 Christ Child chapters represented from around the United States. It was very informative and interesting to talk to the other members and see what the other chapters do in their cities. South Bend is the second largest Chapter in the Christ Child organization. The Christ Child Society is the second largest Catholic not-for-profit agency in the United States. (St Vincent de Paul is #1.)

National Christ Child has found it necessary to increase the national dues from \$7 to \$12 per member. The dues have not increased in 12 years. This increase is partially due to a decline in membership nationwide.

This Girl Scout Service project began when Girl Scout Leader Kim Kirkpatrick attended the "Let Love Shine Dinner and Auction" two years ago!

Kim spoke with Sue Uhran and Deb Low at the event, talking about how Girl Scouts could help our cause. Later, a grant from an anonymous donor brought the necessary funds for purchase of the fleece and cutting tools. The result is evident in the stacks of colorfully embellished scarves for Christ Child Children, lining the shelves and baskets of the coat room.
